HUNTER NURSING NANNIES RENTAL CONTRACT

Agreement made

Between **HUNTER NURSING NANNIES**, PO Box 229, Scone, NSW, 2337,
(The Stud)

being the Owner of the **FOAL** named

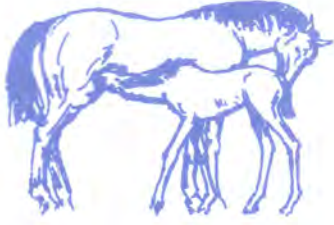
_____ (The Foal)

1. **HUNTER NURSING NANNIES** will foster the **Foal** on to the **Nanny Mare** named _____ at a Contract Fee of **\$6,600.00** (inc GST) payable to the **Stud** within 30 days of fostering.

2. The **Owner** accepts that once the **Foal** is fostered on to the **Nanny Mare** all costs associated with the agistment, maintenance and return of the **Nanny Mare** become the responsibility of the **Owner** until such time as the **Foal** is weaned and the **Nanny Mare** is returned to **HUNTER NURSING NANNIES**. Furthermore the **Owner** agrees to pay any costs associated with getting the **Nanny Mare** back in foal. The **Nanny Mare** must be returned to **HUNTER NURSING NANNIES** in foal. If the **Nanny Mare** is returned not in foal a penalty fee of \$2,200.00 (inc GST) will apply unless the **Owner** can produce a written veterinary report detailing the **Nanny Mare's** reproductive veterinary procedures for the season and a legitimate reason why she is being returned not in foal.

3. The agistment rate of \$27.50/day (inc GST) is payable to the **Stud** if the **Owner** wishes the **Nanny Mare** and **Foal** to remain in the care of **HUNTER NURSING NANNIES** after fostering. Accounts will be rendered monthly and are payable within 30 days.

4. The **Stud** is hereby authorized to engage a Veterinary Surgeon at the **Owners** expense to perform any service or treatment as the **Stud** or its duly authorized representative, in the exercise of absolute discretion, considers necessary. Veterinary Accounts are directly payable to the Veterinarian.

5. **HUNTER NURSING NANNIES** shall not be liable for any loss, damage or claims of whatsoever nature or howsoever arising from injury, death or illness of the **Foal** whilst fostering onto and once fostered on to a **Nanny Mare** or under the care or control of the **Stud**, its employees or agents.

6. All monies due to the **Stud** under this contract shall be paid by the **Owner** within 30 days of invoicing. If monies owing are not paid when due **HUNTER NURSING NANNIES** reserves the right to reclaim the mare from wherever she may be residing and further actions will be taken to recoup all monies owing.

7. This contract shall be binding upon both the **Stud** and the **Owner** when accepted by the **Stud** and is not transferable to any other **Owner**. This contract is not valid unless completed in full and signed by both the **Stud** and the **Owner**.

8. If the **Owner** fails to pay the monies owing to the **Stud** by the date they are due then the person who signs this contract on behalf of the **Owner** agrees that he or she is personally liable to pay on demand to the **Stud** the monies owing by the **Owner** to the **Stud** under this Contract.
