Stallion Service (AI) Contract

Agreement made between:

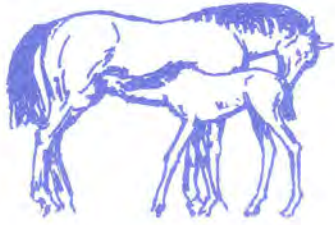
HUNTER NURSING NANNIES, PO Box 229, Scone, NSW, 2337 (The Stud)

And _____ (The Owner)

of _____

being the owner of a Mare named _____ (The Mare).

1. The owner agrees to have the Mare serviced via AI by the Stallion named _____ (The Stallion) at a Service Fee of _____ (inc GST). The full Service Fee is payable to the Stud within 30 days from the date of invoice issued by the Stud on a 45 day positive pregnancy test certified by a veterinary surgeon. If the mare is not in foal at 45 days post service a veterinary certificate from an independent practising Australian Veterinarian must be supplied to the Stud stating that the mare is not in foal otherwise the full Service Fee is still payable.
2. Service Certificates will be issued upon receipt of full payment of all fees invoiced by both the Stud and it's Agents. Failure to pay all Fees by the due date will result in the Service Certificate being withheld.
3. The Mare will not be serviced by the Stallion until all Contracts have been completed and signed and returned to the Stud and it's Agents.
4. The Owner hereby warrants that:
 - (i) He/she is the registered Owner of the Mare;
 - (ii) the disclosed breeding history of the Mare is true and correct;
 - (iii) the Mare is not fractious and is free of injury, illness or disease and is in sound breeding condition.
5. The Owner must correctly identify the Mare on delivery to or collection from the Stud or it's Agents and provide Identification Papers where applicable. The Stud will not be responsible for any problem which arises as a consequence of the delivery or collection of the wrong Mare to or from the Stud or it's Agents.
6. The Owner agrees to indemnify the Stud and it's Agents and hold them free from all liability at law or otherwise, in relation to any loss, damage, injury or claims of whatsoever nature of howsoever arising from injury, death, disease or illness of the Mare or her progeny while under the care or control of the Stud, its employees or Agents.
7. The Stud shall endeavour to provide availability of the Stallion but shall not be liable for any temporary or permanent unavailability of the Stallion for any reason whatsoever.
8. Should the Stallion die or become unfit for service, or should the Mare die or become unfit to breed, this Contract shall become Null and Void.
9. This Contract shall be binding upon the Stud and the Owner when accepted by the Stud and is not transferable to any other Owner or Mare. This Contract is not valid unless completed in full.

10. The Mare is entitled to a Free Return in the following Breeding Season if she fails to produce a live foal where all of the following criteria are met and is subject to the Stallion standing at the Stud in the said year:

- (i) The Owner of the Mare has paid the full Service Fee within the time period specified in Clause 1.
- (ii) The Mare returns a 45 day positive pregnancy test;
- (iii) The Mare subsequently aborts or gives birth to a dead foal or a live foal that fails to stand and suck within 24 hours of birth as certified in writing by a qualified independent veterinary surgeon.

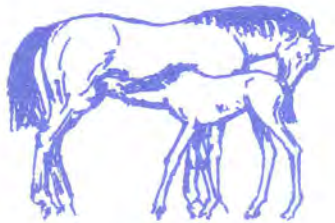
11. It is an express condition of this Contract that HUNTER NURSING NANNIES shall have a lien over the Mare and any progeny in respect of any fees or charges hereunder which are unpaid and further HUNTER NURSING NANNIES shall have the power to sell the Mare and any progeny to recover such unpaid fees or charges should same not be paid within ninety (90) days after the account has been rendered and in this respect the Owner appoints HUNTER NURSING NANNIES as the Owner's Attorney with the power to sell the Mare and progeny if such fees or charges are unpaid as aforesaid.

12. If the Owner fails to pay the monies owing to the Stud by the date they are due then the person who signs this contract on behalf of the Mare Owner agrees that he or she is personally liable to pay on demand to the Stud the monies owing by the Owner to the Stud under this Contract.
